Dear Parent/Guardian:

All school-aged children in Virginia must attend school, and we are very excited that you have chosen to allow your child to attend Danville Public Schools. In order to plan for instruction, transportation, and nutrition, we need you to complete the "Registration for School Reopening Form" to register your child for program participation. If your child did not attend Danville Public Schools last year, you will have to register him/her at the appropriate zoned school, as well. At a later date, you will be required to complete additional information required by your child's school. If you have completed this form electronically, you do not need to complete it again.

Please note, compulsory attendance is required based on the Virginia Compulsory Attendance Law § 22.1-254.

Every parent, guardian, or other person in the Commonwealth having control or charge of any child who will have reached the fifth birthday on or before September 30 of any school year and who has not passed the eighteenth birthday shall, during the period of each year the public schools are in session and for the same number of days and hours per day as the public schools, cause such child to attend a public school or a private, denominational, or parochial school or have such child taught by a tutor or teacher of qualifications prescribed by the Board of Education and approved by the division superintendent, or provide for home instruction of such child as described in § 22.1-254.1.
